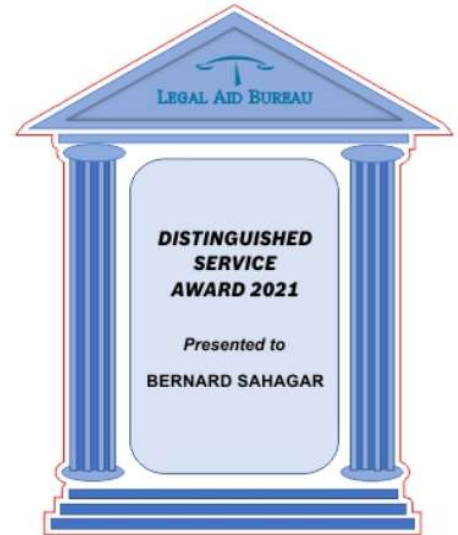


## **Legal Aid Bureau (“LAB”) Distinguished Service Award 2021**
